Jeffrey Hollett Serving Vets - Meeting 5 Basic Needs!

The Valley Patriot this March met with Haverhill's Veteran Services Director, US Army and Massachusetts National Guard Veteran Jeffrey Hollett and discussed the five basic needs of our Nation's Veterans. Most Veterans consider those needs to be

housing, health care, access to education, employment, and most importantly, support and fellowship from family, friends, and fellow Veterans. Since retiring from the Massachusetts National Guard, Jeffrey Hollett has served in Veterans services, working in the City of Lynn, serving Veterans in the Town of Dracut, and now he serves our Veterans

residing in the City of Haverhill. 2,890 Haverhill residents declared Veteran's status when they filled the most recent US Census. Talking with Jeffrey Hollett, he feels that number is low, and estimates the number of Veterans in Haverhill, Massachusetts to be around 4,000. The first item Jeff Hollett discussed with the Valley Patriot was housing.

-Housing: According to Jeff, Haverhill, and the Merrimack Valley have several dynamic Housing referral agencies that we work with dependent upon the Veteran or their family's needs. Many housing resources are available through the Haverhill Housing Authority, the Haverhill Veterans Northeast Outreach Center, Community Action Incorporated, Community Team Incorporated, Clear Path New England, Maloney Properties, the Newburyport Housing Authority, and the relatively new, non-profit Massachusetts Housing Navigator. One of the rising challenges is that of a growing number of Homeless Veterans are migrating to our city. Veterans contacting Jeff's office in need of housing, are from across the state, out of state, and in many cases originally from Haverhill. Housing is a concern affecting all of us and is a focus point for everyone in the human services industry along with rising mental health issues. Jeffrey Hollett stated it this way, "It is important to remember though that these two issues (housing and mental health) are not always linked together."



Any Massachusetts Veterans, especially those with dependent children, who find themselves at risk of becoming homeless, should reach out to their community's Veterans Services department as soon as the problem arises.

-Health Care: Jeffrey Hollett and I discussed the rising number of physical and mental health issues among our Veterans. We discussed a myriad of resources available to address the physical and mental health of their needs. Jeffrey lauded the work of the Disabled American Veterans Queen

Salisbury Officials Must Fire Lisa Pearsons

Some More Equal Than Others

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness."

These words should ring loudly in the hearts and minds of all Americans, although, given the declining trajectory of America's public education system, that assumption is no longer a given. These words, of course, are from our Declaration of Independence, that document we celebrate with our modern-day rockets red glaring.

Sadly, some have called our celebration of independence a white supremacists' holiday, and the recent creation of the federal holiday known as Juneteenth is a reminder that many in our woke society still bear the pains and chains of white guilt.

That is not to suggest that those pains and chains are in any way commensurate with the real pains and chains of African Americans during the age of slavery and the many decades after its abolition.

In many critical aspects, the ideal of equality for all engendered in our

founding documents was anything but. Rather, when America was born, equality was the exclusive province of white males who were landowners. Nevertheless, it was a revolutionary concept put into practice as western society emerged from a feudal structure dominated by kings and lords to a more egalitarian and enlightened framework championed by the likes of Thomas Paine and others.

From the birth of America until today, there has been an inexorable movement to bring the ideal of equality to all Americans. This movement was always sparked by the civil protest of those groups who were left on the outside looking in upon America's promise of equality. The Suffragettes, the Civil Rights Movement, Same Sex Marriage, and other causes have expanded the circle of Americans entitled to the benefits of equal protection under the law.

It seems that finally America has begun the true fulfillment of the proclaimed self-evident truth that all people are created equal. Sadly, having attained this lofty goal, at least in its legal framework, progressives in today's America want to cut off the legs of this hard-fought legal pedestal.

While bubbling beneath the surface

for a decade or more, this attack on American equality rose

to the surface on Joe Biden's first day in office when he issued his "Executive Order On Advancing Racial Equity and Support for Underserved Communities Through the Federal Government."

The order exclaims that there are "entrenched disparities in our laws and public policies, and in our public and private institutions.... And that America is rife with "systemic racism."

Despite initial barriers to achieving true equality at the founding of America, our legal system has marched toward establishing a "system" that guarantees everyone equal treatment. The prohibition for governments and private groups to discriminate against a plethora of protected classes is as much a bedrock of our system as the 14th Amendment itself.

There was a time when racial segregation in schools and public places was legal, a time when homosexuality and interracial marriage were illegal,

a time not too long ago when same sex marriage was illegal. These legal obstructions to equality have been stricken down in our march toward a system that is anything but racist or otherwise discriminatory.

With the advent of "equity" as the new basis for government action, as well as private entities who benefit in any way from government funding, America has undone all of the good of the past two hundred plus years since its founding.

Equity means the automatic disqualification of people based simply because of their gender or race. A prime example was Joe Biden's nomination for a Supreme Court Justice. He stated unequivocally that his selection would be a woman of color.

This pronouncement meant that any qualified man and any qualified white woman was immediately disqualified because of the gender or race. Is that what we want to embrace in America? Is that equal treatment under the law as guaranteed by the 14th Amendment?

Do we really want to resurrect the racial, gender and other identity barriers that plagued America for so long?

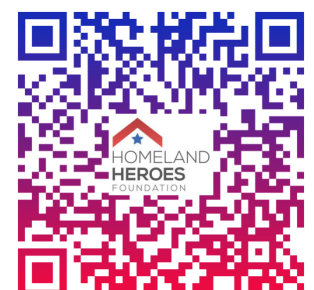

MA Senate's Achievements in March

Amidst a flurry of legislative activity, myself and my colleagues in the Massachusetts Senate have been hard at work this month, addressing a myriad of pressing issues impacting residents across the Commonwealth. From passing significant laws to gearing up for this year's budget discussions, engaging with constituent cases, to attending various events throughout Haverhill, Lawrence, and Methuen, I have been actively fulfilling my commitment to serving the needs of the First Essex District. With a focus on public safety, consumer protections, and access to quality education and care, the Senate's recent bill passing underscores its dedication to addressing key challenges and advancing the well-being of all Massachusetts residents. We also passed legislations that permanently codifies outdoor dining flexibility made popular during the height of the COVID-19 pandemic. Below I will go into more details about four of the major legislations that we passed.

Expanding Early Education and Care
 March 14th saw the passage of the EARLY ED Act, an ambitious initiative aimed at improving access to high-

quality early education and care. By making the Commonwealth Cares for Children (C3) grant program permanent and expanding subsidy eligibility, the bill seeks to ensure affordability and readiness for youth while driving economic development.

The legislation also prioritizes educator compensation, establishes innovative public-private partnerships, and introduces several measures to enhance program sustainability and accessibility. With the unanimous support of the Senate, these bills reflect a commitment to addressing pressing issues facing Massachusetts residents. As the legislative process moves forward, the Senate remains dedicated to promoting public safety, consumer protections, and access to quality education and care for all.

Preventing Abuse and Exploitation Online

On March 21st, the Senate unanimously approved An Act to Prevent Abuse and Exploitation, a bipartisan effort to combat the dissemination of sexually explicit images or videos without an individual's consent. Championed by Senator John F. Keenan (D-Quincy), the bill, designated as S.2073, not only criminalizes the

sharing of indecent visuals but also establishes a comprehensive educational diversion program targeting adolescents.

Under the legislation, the Office of the Child Advocate (OCA) will develop and implement educational programs addressing the consequences of sexting and online indecency. Furthermore, the bill defines coercive control and provides avenues for victims to seek legal protection against such behaviors.

Enhancing Firefighter Safety

In the wake of heartbreaking tragedies, such as the devastating nine-alarm fire that shook the Back Bay a decade ago, claiming the lives of two Boston firefighters, the Senate took decisive action on March 28th by passing S.1485. This legislation mandates the establishment of a public database cataloging violations linked to hot work processes. With a focus on welding, plasma cutting, and other spark-producing construction activities, the bill stands as a crucial step towards enhancing transparency and safety for workers in these fields.

Protecting Consumer Rights

On March 28th, the Massachusetts Senate unanimously approved the Debt Collection Fairness Act, S.2713, signaling a resolute commitment to shielding consumers from the perils of predatory debt collection practices. This landmark legislation aims to overhaul debt collection procedures, offering crucial safeguards to individuals facing financial litigation. Notably, the bill slashes interest rates on consumer debt judgments from 12% to 3%, a move set to provide substantial relief to communities of color burdened by the weight of old debts acquired by collection agencies at a fraction of their original value. Moreover, the Act



establishes protections against wage garnishment, ensuring that at least \$975 per week remains shielded from seizure due to debt obligations.

In a significant stride towards financial justice, the legislation clarifies that no individual can be incarcerated for failure to repay consumer debts, alleviating the anxieties of those grappling with financial hardships. Additionally, the bill streamlines the debt collection process by shortening the timeframe for legal action from six years to five years, fostering fairness and efficiency in debt-related legal proceedings. With the passage of the Debt Collection Fairness Act, the Massachusetts Senate underscores its unwavering dedication to safeguarding consumer rights and promoting equitable financial practices across the Commonwealth. ♦

Corrupt Haverhill Officials Continue Abuse of Power

For more than 200 years we could always rely on agencies of the media, local, state, and federal government to hold each other accountable when one goes astray and abuses their power.

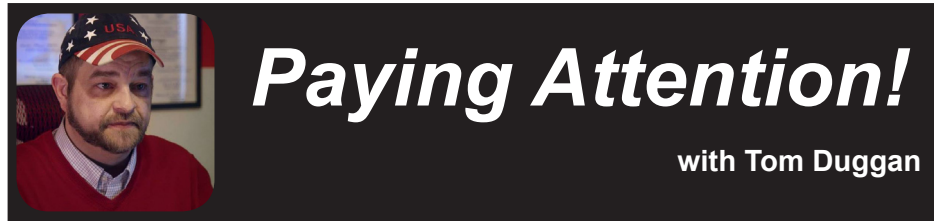
That concept is no more.

Case and Point: whatever you think about former Haverhill School Committeeman Scott Wood, he is being punished for committing a carnal sin in today's political climate. He ran for office against an authoritarian who had the support of the corrupt political machine in Haverhill.

For that, Wood was wrongly accused of being a racist, complete with a bogus allegation that he might have... maybe... sent a text message 25 years ago, using the "N" word.

Mind you, this was orchestrated with no proof of an actual text message, no chain of custody showing it came from his phone, no IP address, no actual evidence that it was even real, or anything more than something typed up on a word document twenty minutes ago.

Yet, the Haverhill City Council used the power of their governmental body to

Wood is also a police officer in Haverhill, so in order to punish him further for campaigning against the "equity diversity, and inclusion" mob, he was illegally refused a shift work.

That's right, Chief Pistone didn't fire him legally, he just stopped giving Wood a shift, meaning Wood can't pay his mortgage.

Even after The Valley Patriot filed

an open meeting law violation against Haverhill officials, - and the Attorney General spanked the Haverhill Council for breaking the law - the hacks in Haverhill government didn't stop. In fact, they went even further, spitting in the face of the voters and the taxpayers.

Last month, Mayor Barrett engaged in yet another open meeting law violation to punish Wood for daring to challenge her quest for power. Only this time, she had the help of hack School Committeeman Paul Magliochetti, who himself has a shady background that we will be talking about at a future date.

As Scott Wood sits on the Whittier Tech School Board and is appointed

by the Haverhill School Committee, Magliochetti and Barrett enlisted the assistance of the other school committee members to change the rules, policies, and procedures of appointing members of the Whittier Tech committee, to throw Wood off that board, even though his term wasn't up yet.

To accomplish this, they discussed the issue in secret, conspired to change the policies ... violating their own procedures ... voted at an illegal meeting without putting the item on the agenda, and not notifying the public as required by law.

Then, they were so cocky and arrogant in their law breaking - knowing that the levers of power in state government would do nothing to hold them accountable - that they publicly posted Wood's job while he was still there, and sent him a letter notifying him he was terminated from the board.

So, The Valley Patriot filed yet another open meeting law complaint, which will result in yet another slap on the wrist for Barrett and her cronies, who will continue to abuse their power five minutes after everyone stops paying attention again!

Where was WHAV Radio in all this? Well, they were cheering Barrett on and providing cover for the corrupt political insiders, only mentioning the possibility of wrongdoing after The Valley Patriot took action weeks after the incident. Which means Barrett and the hack insiders like Magliochetti will do it again, and again, not just to Scott Wood, but anyone else who dares to challenge their obsession with power.

Any why not?

As long as they yell "equity, diversity, and inclusion" really, really loudly, corrupt government officials can get away with - literally - anything they want. ♦

A New Hope for Whittier

After the ballot question to build a new Whittier Technical High School was soundly defeated a few months ago, the school's future was uncertain. As somebody who has toured the campus multiple times, we need a new school or a total renovation. The current status quo at Whittier is not sustainable for the next generation of students looking for a technical education.

This past week, we received news from the Healy-Driscoll administration that a light might be at the end of the tunnel. The administration has partnered with Northern Essex Community College to explore a possible shared campus model for Whittier Tech and Northern Essex.

The administration, in their press release, summarized the partnership as "NECC and WT will explore ways to create a new, modern facility for Whittier Tech, allow for expanded access to postsecondary education across northeastern Massachusetts, and increase enrollment capacity at both institutions and make them more affordable. It will also open up new avenues for potential additional funding sources beyond cities and towns in the Merrimack Valley."

First off, I'd like to thank the Governor, Lieutenant Governor, and Lane Glenn, President of Northern Essex Community College, for exploring this outside-the-box opportunity as a way to solve the Whittier Tech problem. I think we can all agree that Whittier Tech plays a vital role in the economy and workforce development of the Merrimack Valley. In this day and age where we need to open up more opportunities for students to have the ability to pursue a technical education, Northern Essex Community College in the Healy-Driscoll administration has answered the call.

My official quote on the topic of Whittier and Northern Essex is below.

"Partnerships between our vocational schools and community colleges are crucial for connecting our young people with the training and education they need to thrive in the workforce. I am thrilled to see two Merrimack Valley institutions unite to address a tough situation with creativity and collaboration. Thank you to the Healy-Driscoll Administration for fostering a regional solution that centers our students, educators, and diverse community needs."

In the following months, Valley Patriot, I will detail the House Budget



which should be released sometime during April. I will highlight the funding the House appropriates for the 15th Essex District. I will also introduce my new legislative aid to the readers of the Valley Patriot. I want to congratulate my current legislative aid, Emily Kibbe, on taking a position with the Massachusetts AFL-CIO.

Emily has done a fantastic job working with me to help everyone in the 15th Essex. I wish her the best as she moves on to her next exciting opportunity.

Sexual Assault, Harassment & Cover Ups

Happy Spring, Valley Patriot readers!

It shouldn't come as a surprise that I'm a big fan of spring – mostly because this time of year very much reminds me of my overarching goal as your State Auditor: that each day should bring a little bit more sunlight!

Let's also take a moment, coming out of March - which was Women's History Month - to celebrate the strength, resilience, and remarkable achievements and contributions of women!

Recognizing successes are important, but, so too is reflecting on the challenges – both past and present – of how much more work remains.

I reflect often on my office's duty to ensure every person has a fair shake, no matter our family background, bank balance, zip code, or - yes - their gender.

Here's a look at a few of the issues we're tackling to support women in their continued fight for equality:

* Despite all the progress we've seen, there are still significant and unfair gender disparities persisting in the workplace. That's why many of my office's audits are prioritizing a review of pay equity. A 2023 study from the Boston Women's Workforce Council showed a gender gap of approximately \$24,000 in average base compensation between men and women.

That same study found that, on average, men's performance pay was 3x that of women.¹ It would seem this disparity exists for no other reason than the difference in gender. I will continue to use my role to ensure we recognize agencies that have made significant advances in pay equity, while recommending changes for those state entities with more work to do. We encourage all business owners to consider this issue and take steps to

* Nondisclosure Agreements (NDAs) paid for with taxpayer dollars are an inappropriate use of public funds. All people - women included - deserve a workplace free of violence, abuse, harassment, and discrimination; and one where perpetrators of such acts are held accountable. My team's audits seek to review and report on state agencies' policies regarding the past and present use of taxpayer funded settlement agreements with nondisclosure clauses. It is unacceptable for our tax dollars to continue to cover up abuse in government.

* One area where we can all make a difference is in supporting women-owned businesses. Many of you may not be familiar with the Massachusetts Supplier Diversity Office (SDO), which we are currently auditing; their role is to ensure that diverse businesses (women, veteran, minority, service-disabled veteran, disability, and LGBT-owned)

have equitable access to state contract opportunities and awards. Reporting from the SDO shows that only a small fraction of the billions awarded in state contracts is awarded to women. This evidences a glaring gap in opportunity and access to state contracts for women-owned businesses. Our current audit of the Supplier Diversity Office will help ensure that it's delivering on its mission as effectively as possible. Moreover, in our other state agency audits, we will examine whether agencies are supporting and contracting with vendors registered with the Supplier Diversity Office, to ensure that diverse Massachusetts business owners have an equitable piece of the pie.

* The YWCA reports that nearly 1 in 3 women have experienced rape, physical violence, and/or stalking by an intimate partner in their lives.² Moreover, they report that over 4,000 people in Massachusetts are sexually assaulted

each year. These statistics are significant when reflecting on our recently completed audit of the Massachusetts Sex Offender Registry Board (SORB), finding approximately 1/3 of incarcerated offenders were never assigned a sex offender level prior to their release. In fact, an offender was released on average 170 days before being assigned a level - with the longest delay taking over 700 days. We all expect SORB to do its job - to promote public safety by educating and informing the public to prevent further victimizations. SORB is charged with registering and classifying convicted sex offenders so that the public understands the risk in their community, and offenders' risk of re-offense and the danger they pose. SORB's lax oversight puts everyone at risk. I will continue to ensure that the state agencies responsible for our safety are held accountable.

Through each of our audits and investigations, my team works tirelessly to promote accountability, transparency, accessibility, and equity in government – ensuring that taxpayer dollars are being spent responsibly and effectively.

Please join with me in taking a moment to recommit ourselves to the ongoing work of advancing women's rights - for our mothers, daughters, sisters, aunts, cousins, friends, and neighbors.

A Family Legacy of Giving at Daybreak

There's a new worker at the Daybreak Homeless shelter in Lawrence and while his surname is quite familiar to those who have been there a while, his youth and enthusiasm make him a valuable member of the team at the Daybreak homeless shelter on Winter Street in Lawrence.

Meet Mike Pappalardo, the 18-year-old college student from the University of Massachusetts at Lowell who has been coming to Daybreak with his mom since he was a kid, a mom who is now the CEO of the Greater Lawrence Psychological Center which oversees the operations at Daybreak.

"I used to come in with my mom all the time and I was always fascinated by what was going on here," Pappalardo told The Valley Patriot. "Now I get to come back and actually work here and I love it."

The Daybreak shelter is one of two "wet shelters" in the state, meaning that homeless individuals will not be turned away if they show up high or intoxicated. The shelter is a rickety combination of two trailers soldered together holding a capacity of about 55 people each night.

"The thing I love most about this job is making connections with people. You know, some of them (the

homeless) feel like they are ignored on the streets, like they are invisible. When they come here, though, it's like home for them. You get to know them, what their story is, why they are where they are in life. That connection with them is really important. It's the one thing we see that motivates some of them to try harder, knowing someone is rooting for them."

Pappalardo says it's the environment at Daybreak that makes it different from most other shelters. "It's nice, everyone from the staff to the guest, the volunteers, everyone is friendly and helpful so it doesn't really feel like work.

"When I come in every day, I usually try to start off by helping clean and do whatever tasks need to be taken care of. Sometimes it's doing dishes, laundry, sweeping, fixing something that has broken, or just talking to guests and checking people in. Sometimes, depending on who's here I will do the dinners and set up the kitchen, put out coffee and juice."

Pappalardo, who is only 18 years old, says that helping people is why he keeps coming back.

"I don't even really think of them as homeless; they are just people who need a little help, and talking to them about what they need and how we can find creative ways

State Committee Retires Republican Relic Ron Kaufman

entities? On whose behalf are these services provided? What is your compensation?

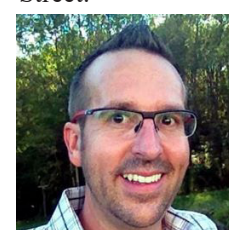

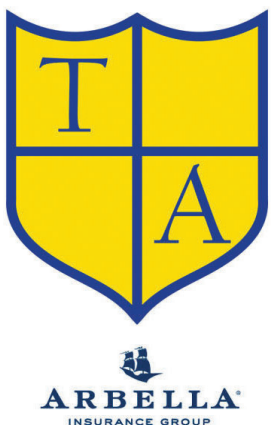

to fulfill those needs is a challenge that makes the job interesting and different every day.”

Pappalardo is majoring in finance in college and says that one of the things he likes about Daybreak is the availability of different programs for the guests. We help them get into detox if they have addiction problems, we have a program for job training and some guests come in and do so well they qualify for an apartment.

“I love that,” he says. “Watching some of the guests move on and move out to their own place, working in a steady job after spending a lot of time thinking life was hopeless. It’s motivating. But, it doesn’t just motivate the other guests to see someone moving on, but it motivates me too. I learn a lot about people, and hope, and never giving up.”

Pappalardo says that Daybreak is like a “big family.”

“From the minute you come in you see people helping out with chores, taking out the trash, cleaning the dorms, there’s

a sense of pride here that you wouldn’t expect at a homeless shelter. I think that’s why there are so many success stories here.”

Pappalardo says the newest addition to the Daybreak program roster is the street outreach team.

“Our new outreach program is when the team goes out into the community to try and get some of the homeless to come in from the streets. They offer services like getting people into detox, bringing them clothes and food and blankets if they aren’t ready to come in from the streets. You know, it sounds weird, but some people don’t want to come into the shelter. So, they try to build a relationship with them and let them know we are here when they are ready.”

The Gr. Lawrence Psychological Center is holding a fundraiser on Saturday May 4th, called “Diamonds are for Derby” to raise money for Daybreak, Pegasus House, and Women’s View Programs. Get your tickets at PsychologicalCenter.com. ♦

The Lowell Veterans' Center

Providing professional, safe, and confidential personal and readjustment counseling to eligible veterans and their families in our community,

Director Elisabeth Parrott of the Lowell Vet Center emphasized that veterans coming through the door of the Lowell Vet Center have entered a judgement free zone. Kane could hear in Elisabeth's voice that she meant what she said, and he thought this is the key component, veterans seeking services could be themselves in this space. Elisabeth oversees a staff of seven clinicians. Unlike a community health center clinicians at the vet center are knowledgeable of military terminology and lifestyle. This is a community where our very important military community members may participate in individual, family, or group support.

Elisabeth explained to Kane that Services are free and records are kept confidential. Although the vet center is funded through the Department of Veteran Affairs records are kept completely separate. Neither the Department of Veteran Affairs nor the Department of Defense have access to these records. Kane knows that our military members have specific needs often not addressed in a typical

community-based clinic. Sharing what was observed in a combat zone is received best by counselors and other veterans "that get it."

Kane learned in a workshop that people have normal reactions to observing events that are mentally disturbing and abnormal to see. Having a safe place to process this information and make sense of feelings is a much needed and deserved resource. Elisabeth explained to Kane that readjustment to civilian life is extremely challenging and normal. This made a lot of sense to Kane. Serving in a combat zone or knowing you are tasked with the security of our country, is very important work. Frankly, civilian life may feel a bit mundane after that in some ways and rewarding in others.

Kane asked who is eligible for services at the Vet Center in Lowell? Elisabeth explained that eligible members include:

Veterans that served in a hostile environment or combat zone including Reservists and members of the National Guard.

Military members that provided mortuary services or direct emergency medical care to treat the casualties of war while on active duty.

Members of unmanned aerial vehicle crew that provided direct support to those in a combat area.

Served active duty in response to a

national disaster or civil disorder under orders of the President.

Current or former members of the Coastguard, who participated in drug interdiction.

Current members of the Reserve in need of addressing behavioral health or psychological trauma related to military service.

Members who received services from a Vet center before January 2, 2013

Members who experienced military sexual trauma

And members who currently use any covered VA educational assistance benefits.

Elisabeth made it clear if you are a veteran and are in need of services that do not meet this criteria, please still check in so the team may provide referrals to meet your needs off site. Eligible participants do not need to be enrolled in VA health or a disability to receive services. Kane felt very comfortable talking to Elisabeth. She has a friendly voice and is quite passionate about the important work she and her staff do daily.

In terms of family involvement and care, Elisabeth explained that couples and family counseling is available to support their veteran family member. A few examples of offerings include communication support and education and parenting topics. The clinic also



supports gold star families with grief and bereavement if their service member died while serving on active duty. Elisabeth reported that eligibility for bereavement services has expanded recently to include families of veterans who died by suicide. Kane knows how important family is in the reintegration process. He was happy to learn that family may be included in the support process.

Elisabeth was excited to report that besides the Lowell location on 10 George Street in Lowell three satellite locations

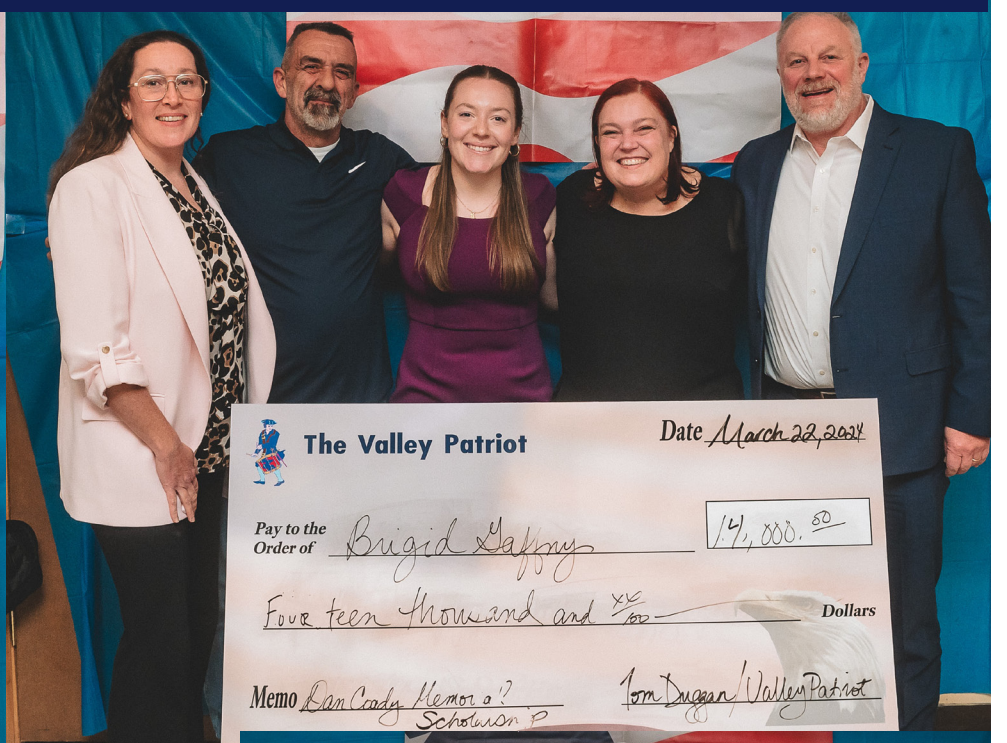

The Revolving Door of Criminal Chaos

Those who ignore history are doomed to repeat it—a stark warning during turbulent periods of our nation’s journey. One of my friends, Bob Rapazzo, is a world traveler who has been pictured outside the Great Pyramid of Giza and walked the same steps of ancient Greek philosophers. He once worked for the famous Bishop’s Restaurant in Lawrence. Are Judges in MA Above the Law?

How Come Nobody investigates Corrupt Judges Anymore?

Question: What do you call a dishonest lawyer who's too lazy to chase an ambulance? Answer: A judge.

Every day I watch people on television complaining about crime, open borders, and the Biden family's shady business dealings. However, I see the government and most of the media aim their attention at Donald Trump for paying hush money, attempting to overthrow the government, and trying to cancel Christmas.

Invariably someone always says that nobody, including a former president, is above the law. Is that really true?

Rosie Ruiz was the first female (biological) runner who crossed the finish line at the 1980 Boston Marathon. But did she win? It was later found out that Ruiz had jumped into the race about a mile before the finish line ahead of the actual woman's division leader, Jacqueline Gareau. It was also discovered that she had taken the subway during part of the New York Marathon to achieve a qualifying time for the Boston Marathon.

It took the Boston Athletic Association only eight days to discover Ruiz' deception and strip her of the title and award it to Gareau. The BAA set up a mock finish line at the 1981 Marathon and had Gareau break the tape to give her back a little of the glory that she had worked so hard for and what had been stolen from her. That's at least a gallant attempt at justice.

Lance Armstrong won a record seven Tour De France bicycle races. Or did he? The Sunday Times in the UK published a story that Armstrong was using performance enhancing drugs. Armstrong sued the paper for one million pounds and settled for three hundred thousand in 2006. When it was discovered that Armstrong was juicing, the sports columnist who wrote the story sued Armstrong and settled for an undisclosed amount in 2012. That's some justice, but the damage to the writer's reputation had already been done.

I became an honest attorney (oxymoron) in October 2010 and have spent most of my time since then trying to prove that cases in this state are being fixed by dishonest lawyers and corrupt judges. I have specifically accused the Massachusetts Supreme Judicial Court of allowing lower court judges to get away with this. Where does one present evidence of judicial corruption and get justice?

I've never been given a hearing to present any evidence of the corruption since I began this crusade over eight years ago. I was ordered to pay \$18k in attorney fees for making these allegations. The SJC ordered the Board of Bar Overseers to begin a secret investigation of me in December of 2019.

I was formally charged in June of 2023 with making false statements against numerous lawyers and judges operating in this state. I've already stood trial for three days at the BBO headquarters in Boston and scheduled for another four in April.

I tried to obtain general public information on how the state court system operates on March 18 to make my defense at the BBO's show trial. I was thrown out of the Newburyport Superior Courthouse for asking too many questions. I was arrested for trespassing by the Massachusetts State Police the next day when I tried to get back into the courthouse to finish my investigation. I spent most of the day in the state police and district court lockups before being arraigned and released on my own recognizance.

I've been ordered to stay away from the Lawrence, Salem, and Newburyport courthouses pending the outcome of the trespassing charge against me. This bars me from getting the information I need to defend myself at the BBO's trial. What's happening here is not supposed to happen outside of a third world banana republic. In this country everyone is Constitutionally guaranteed due process in the 'halls of justice' because no one is above the law. To paraphrase Howie Carr; 'the only justice you might get is not in a courtroom but out in the halls and 2% of the judges in this state are trying to give the other 98% a good name'.

Obviously, judges are above the law until they get caught AND tried in the court of public opinion. Otherwise, any corruption in a judicial system will continue to spread and grow like a malignant cancer. Apathy is a crooked judge's best friend. Please help me expose this disease by logging on to massbbo.org on the morning of April 5, click on View Calendar, and then my name for a livestream to my professional flogging. Or come to the Newburyport District court at 8:30 and watch me fight a bogus trespass charge. Bear witness to the evidence I have to prove my allegations or watch the SJC finally silence me once and for all. ♦

City Chapter 2, on 112A East Haverhill Street in Lawrence, Massachusetts. The men and women at the DAV Chapter in Lawrence, are considered by most Veterans to be experts at navigating the forms and eligibility requirements needed to receive health care from the Veterans Administration. Veterans in need of assistance navigating the Veterans Administration's health care system should reach out to the nearest Disabled American Veterans Chapter and their community's Veterans Services Department.

Jeffrey Hollett said "As a VSO, we want to guide our clients to understand what is available through the Veterans Administration's healthcare to them." He further said, "we currently have a huge uptick in the VA Healthcare system expanding their support services for our Nations Veterans."

-Education: The University of Massachusetts at Lowell, Middlesex Community College, and Northern Essex Community College all have Veteran's Resources Departments. Veterans interested in attending college on the GI Bill, should reach out to the schools Veteran's Center for an appointment. The State of Massachusetts has a website at Mass.Gov, which offers information on apprenticeships for Veterans.

Apprenticeships can help Veterans, National Guard, and Reserve members enter in-demand fields and get on-the-job training in a range of industries, from building trades to technology. The GI Bill can be used for many of these trade or technical school programs.

Jeff pointed out that Massachusetts Veterans Certifying Officials at the schools have been instrumental in getting Massachusetts Veterans the educational benefits they earned serving our Nation.

-Employment: On the Mass.gov website the MassHire Department of Career Services offers career programs and services to veterans to help them find jobs. The unemployment rate in Massachusetts is 2.9 percent. (February 2024) The number of applicants each year to take the State Civil Service Exams for law enforcement and firefighting careers is dropping, leaving a great opportunity for young Veterans seeking a second career. In New Hampshire, the unemployment rate is even lower, 2.6 percent (February 2024), so all Veterans will find a robust job market throughout the Merrimack Valley. Jeff cited Christopher Feugill of the MassHire Merrimack Valley Career Center and Wingate Veterans Representative Patricia Healy as "our go to for employment resources for helping our Veterans find good paying jobs."

-Fellowship: One of the most important and most overlooked needs of our Nation's Veterans and their families. In Haverhill, Massachusetts, there is a Veterans of Foreign Wars Post 29, American Legion Post 4, and American Veterans Post 147, all are focused on Veterans issues, and all are great organizations to meet at with other Veterans.. Haverhill also has a VA Clinic and two Veterans Northeast Outreach Centers. Jeff singled out WHAV radio for their work connecting Veterans with

other Veterans and community resources.

A member of several Veterans Organizations and active in the Susan Komen Foundation, Charity Navigator in 2023, awarded the foundation four stars (the highest) and a 95% rating. Jeff is dedicated to helping Haverhill Veterans, he firmly pointed out, that any Veteran entering his office, will be assisted, or directed to a resource that can provide that assistance. We discussed an American Legion Post in the Merrimack Valley, that when the Post's members learned of a Veteran who was going to lose his job because his automobile was in need of repair, that Post paid a local mechanic to repair the car so that a Massachusetts Vehicle Inspection sticker could be obtained, and the Veteran could retain his job.

Jeff Hollett enlisted in the US Army shortly after his twenty-first birthday. Initial training was at Fort Jackson, South Carolina, and Fort Gordan, Georgia. Jeff served for six years in South Korea. Subsequent service at Fort Detrick, Maryland, supporting the White House Communications Agency, and a follow-on tour to Okinawa, Japan.

Jeff then transferred to the Massachusetts National Guard. Following the 9.11 attacks, Jeff provided security for the Wachusett Damm in Clinton, Massachusetts. In 2002 he was the Non-Commissioned Officer in Charge of the east entrance to the 2002 Olympic Square during the Winter Olympic Games in Salt Lake City, Utah. This event set a Winter Olympic attendance record that still stands.

He supported relief operations during Hurricanes Irene and Sandy. Jeff deployed twice to Egypt in support of Operation Bright Star, and three times to the Middle East in support of Operation

Iraqi Freedom. During his twenty-seven years of military service, he spent twelve years overseas.

He retired as a Sergeant First Class. Earning the Meritorious Service Medal, Army Commendation Medal, and Army Achievement Medal.

Jeff and his wife Rosie, live in Lynn, Massachusetts, and the couple have a daughter Shannon attending college, their son Joseph is serving in the US Army Reserves and is an Iraq War Veteran. Husband, father, US Army Veteran, who is in his second career, serving his fellow Veterans, Jeff Hollett is a "Hero in our Midst"!

TV TALK with BILL CUSHING

“The Gentlemen”

If you watched Guy Ritchie’s 2019 film ‘The Gentlemen’ and thought you might like to see more of this world then welcome to the new eight-episode Netflix series ‘The Gentlemen’, inspired by the film and my recommendation for this month.

Ritchie, director of such films as ‘Snatch,’ ‘Lock, Stock, and Two Smoking Barrels,’ ‘The Man from U.N.C.L.E.’ as well as the two Sherlock Holmes films starring Robert Downey Jr., wrote and created this series and also handles some of the directing.

This version of ‘The Gentlemen’ stars Theo James as Eddie, the reluctant inheritor of his dead aristocratic father’s title and country estate. After his father’s death, Eddie inherits the Halstead estate which is home to a cannabis facility run by Bobby Glass’ (Ray Winstone) daughter, Susie (Kaya Scodelario).

Becoming a Duke is one thing. But learning about the major cannabis growing operation concealed on his estate’s grounds is quite another, and the bickering and scheming between family members and criminal factions pops off from there.

Uneasy with the criminal enterprise, Eddie initially wants out. But, when his elder brother Freddie (Daniel Ings) gets himself into deep debt, Eddie teams with Susie and learns about how the other side operates. The series focuses on the partnership between Eddie and Susie while also introducing us to the complex web of competing interests in the weed enterprise which leads to all sorts of violence and intrigue.

In addition to its absurd scenarios and abundant amounts of unpleasant characters, the style of ‘The Gentlemen’ adds to the shows fun.

From the picturesque settings and the use of written on-screen text that helps the audience keep the various deals, people and schemes outlined, the show

does a great job at keeping viewers’ attention.

While each of the eight episodes of ‘The Gentlemen’ runs between 42 minutes to a little over an hour long, you never quite feel the length, and that’s primarily because Ritchie’s fast-paced way of telling a story is in full affect.

The performances in the series shouldn’t be overlooked. Theo James does some of his best work here, playing Eddie as the straight man and the pragmatic center, but also making him flawed enough that he remains interesting, and isn’t completely outdone by his more vibrant supporting characters. Giancarlo Esposito is total, malicious classiness as Stanley Johnston, an American billionaire obsessed with buying Eddie’s estate. Esposito brings back the smooth-talking demeanor of his kingpin from ‘Breaking Bad,’ now tailored for Ritchie’s brand of zany dialogue. But the true stand-out is undoubtedly Daniel Ings. His character Freddy is somehow both the most likeable and the most infuriating of them all, while also simply being a riot to watch.

Adapting a perfectly good and fun film into a successful TV series is a lot to ask, and it doesn’t always work out. But I think that ‘The Gentlemen’ actually improved upon the original film, expanding it to tell an even better story.

Although the show has not yet been renewed, it’s highly likely that a second season will be coming. If you’re looking for a fun watch, turn on ‘The Gentlemen’ and strap in for a wild ride.

no more.” NKJV.
